

SpankChain/SPANK.live/SpankPay Privacy Policy

This policy covers how SpankChain.com (“SpankChain”) and SPANK.live treats the statistical and personal information received from site visitors and SpankChain/SPANK.live members. The following policy covers the website SpankChain.com, SPANK.live, Cryptotitties.com and all pages associated with the SpankChain.com domain name. Use of the words “we,” “us,” or “our” in this policy refers to SpankChain, LLC and any or all of its affiliates, and use of the words “you” or “your” refers to you as a SPANK.live site visitor, member or account holder.

Adults Only Website

SPANK.live is an adults only website for persons over the age of 18 (eighteen) and the age of majority in their home and current jurisdictions. For further details on our Code of Conduct and related matters, please see our User Agreement.

What We Collect

When you sign up for an account on SPANK.live, we require that you create a username and password and provide an email address where we can reach you (collectively, “Personal Information”), and we may further request that you provide us with certain information – on an entirely voluntary basis – which may include your zip code, age, sexual orientation and preferences and other demographic information (collectively, “Demographic Information”). We may also collect IP address(es), browser type, browser language, referring URL, platform type, domain names and the date and time of site visits and any other such information that may be available (collectively, “Log File Information”). Personal Information, Demographic Information and Log File Information are, collectively, referred to below as “Account Information.”

We do not collect any information regarding passwords, mnemonic phrases or personal access data associated with any SpankChain cryptocurrency wallet (or, “SpankPay”) generated in connection with a SPANK.live member account.

We may send one or more cookies – a small file containing a string of characters that uniquely identifies the browser you use to visit SPANK.live – to your browser during any browsing session. Cookies make it possible to store site user preferences and record which portions of our website you and other users are using the most. We may use cookies for the purposes of preventing fraud and improving the quality of our service. You should be aware that SpankChain/SPANK.live/and or SpankPay services might not function properly without cookies enabled.

Use of Information We Collect

Account data will be used to maintain and administer your SPANK.live member account. We may use “cookies,” Log File Information and Demographic Information to improve our site for you by allowing us to tailor your experience according to your preferences and what we think may appeal to you.

Aggregate, non-individual site usage data may be shared with third parties for website administration and optimization purposes including, without limitation, analyzing usage and data flows, maintaining servers, and other aspects relating to maintaining and improving SPANK.live user experience and site functionality.

Security

Appropriate security measures are taken to protect your account and Personal Information against unauthorized access or unauthorized alteration, disclosure or destruction. These measures include internal reviews of our data collection, storage and processing practices. Physical security measures are also taken to prevent unauthorized access to our systems. Your username (but not your password), and your Demographic Information and Usage Information may be revealed to our employees, contractors, and agents on a need-to-know basis in operating, developing or improving our services, or responding to an inquiry or contact from you. As a condition of their employment, contract or association with SPANK.live, these individuals are bound by confidentiality obligations. If they fail to maintain confidentiality, they may be subject to discipline, including termination and criminal prosecution.

Information You Make Available to Others

You are responsible for any information you provide, post or make available to individual and/or groups of users through the platform. You agree that it is your sole responsibility to carefully select the information you upload or post to the platform and what information you choose to make public or otherwise share with other members on the SPANK.live platform. You acknowledge that we are not in any way responsible for information you share through your profile, messages to another member, chat services or any other means on the SPANK.live platform. Should you upload any illegal material, in our sole discretion, we may forward all available and pertinent information to law enforcement without notice.

Disclosures Made as Necessitated by Law or Safety

Although your email address and Demographic Information you choose to provide are generally considered confidential, all information you provide to us in this regard may be shared with other third parties as necessary to comply with legal process or to protect the rights, property or safety of our members. In the event that we believe, in our sole discretion, that your use of the site or service may constitute a violation of any law, we reserve the right to proactively provide all information relating to your account, including account data, to law enforcement and any and all other agencies we may deem appropriate.

Emails From Us and Use of Your Email Address

Your email address may be used by us to contact you. We will not share your email address with anyone except as provided for in this policy. We may send you emails prior to and after you have terminated your membership to our service, until such time as you advise us that you no longer wish to receive email from us. If you no longer wish to receive emails from us, please unsubscribe by sending us an email to hello@spankchain.com. Our emails will fully comply with

the federal CAN-SPAM Act. Please immediately report any emails you may receive, without your prior authorization, that purport to promote SpankChain, SPANK.live, or SpankPay.

Either we or our advertising agencies may use cookies and/or "action tags" to measure advertising effectiveness on an anonymous basis.
